

THE CARE IN CARDIOLOGY

The idea of surgery can be scary to almost anyone. For one woman, heart surgery brought particular apprehension — but the heart care team at Christian Hospital eased her fears and turned it into a positive experience.

Joy McClard, 77, of Edwardsville, Ill., wasn't experiencing any chest pain or shortness of breath. Instead, it was two fainting instances that brought her to the cardiology department at Christian Hospital. Joy had severe aortic stenosis and needed an aortic valve replacement — but she was hesitant. Her own mother had passed away during heart surgery.

The cardiology team at Christian Hospital hoped to reassure Joy by explaining her options. While Joy did not qualify for a transaortic valve replacement (TAVR) at the time, she was offered a minimally invasive approach to open-heart surgery called small-incision sternotomy, which involved only a small incision rather than dividing the whole sternum.

With this approach, Joy could get back to her life sooner with minimal pain. She was still nervous but very graciously kept faith in the Christian Hospital team and trusted them to do their job.

Joy's surgery was a success, and she was amazed with the whole experience. "Every member of the staff treated me wonderfully, and I found great comfort in their personal care and warmth," says Joy. "I cannot give enough praise." To express her gratitude for the extraordinary care she received, Joy penned a letter to the hospital, which was shared with the team of surgeons, cardiologists, nurses and other support staff.

Following her surgery, Joy has returned to her active social life without any complications. She enjoys spending time with her family and her husband,

Daryl, who cared for her throughout her recovery. Joy also loves to play cards and is an avid football and baseball fan.


Whenever possible, the heart care team at Christian Hospital likes to offer their patients the most minimally invasive approach appropriate for their case. They perform a full spectrum of cardiac surgeries, including aortic valve replacements ranging from conventional open-heart surgery with a full sternotomy to TAVR and other advanced procedures such as high-risk percutaneous coronary intervention (PCI). The team can also care for all levels of heart failure and heart attack patients.

Enabling this comprehensive and advanced care right in the community is part of the Christian Hospital Foundation's mission. Every day, patients like Joy are living better, healthier lives because of the compassion and expertise they find at Christian Hospital.

SCHOOL-BASED HEALTH MAKES THE GRADE

The Christian Hospital Foundation's trusted partnership with school-based health centers meets youth where they're at to bring them quality health care and ultimately transform communities.

For nearly three years, the Christian Hospital Foundation and CareSTL Health, formerly Myrtle Hilliard Davis Comprehensive Health Centers, have been working together to offer adequate health care in schools. While CareSTL Health provides school-based health centers with a staff of skilled nurse practitioners and behavioral health counselors, the Christian Hospital Foundation provides the funding to support these much-needed services. This collaborative relationship serves underprivileged communities by meeting students where they spend most of their time — in schools.

A lack of proper health care can cause significant disruptions in education. Research reveals that school-based health centers reduce these issues, delivering results like increased attendance, improved academic performance and better health. Instead of missing school for a few hours or even a few days because of access barriers, students have the ability to have their medical and behavioral health care needs met on campus, maximizing the time spent in the classroom and ensuring they are ready to learn.

For many families, school-based health centers are a vital resource for guidance. One family received a life-changing diagnosis at the suggestion of a behavioral health counselor who noticed their son's changed behavior and recommended he see a doctor. Now, the student is being treated for his condition and enjoys a better academic and home life. His mother shares, "We wouldn't know where to go to if not for the school resources. He's better at communicating with us; he enjoys being around us. Before his diagnosis, his grades were failing. Now he's more focused and engaged."

This story of progress isn't uncommon and wouldn't be possible without the school and health center counselors establishing a trusted bond with one another and the students they serve. CareSTL Health's Director of School-Based Services and Community Partnerships Jasmine Burris shares, "We're proud to be involved because, like our name, we care. We want to make sure students' health needs are met."


Currently, this partnership between the Christian Hospital Foundation and CareSTL Health serves students in the Riverview Gardens School District at Riverview Gardens High School and students in the Hazelwood School District that attend Hazelwood East High School, Hazelwood East Eighth Grade Center and the Hazelwood Opportunity Center. Students can also receive referrals to Christian Hospital for specialty care. Thanks to this partnership, equity across St. Louis communities is becoming a reality.

CURING THE CARE INEQUITY IN ST. LOUIS

At the age of 16, Arnold Bullock, MD, initially signed up for a Saturday lecture series to meet girls, but ended up leaving with a book's worth of notes and a newfound passion for medicine. Today, he's being recognized as 'Physician of the Year' by the Christian Hospital Foundation, having studied under many renowned African-American doctors along the way.

On this honor, Dr. Bullock expresses gratitude to his team and makes it clear that it was a collective achievement for his skilled colleagues and staff in the urology department and for Christian Hospital as a whole. "This means our group is being recognized for the care we're trying to provide. There's an ease of providing the best care to all of our patients, without regard to any other factors," he says.

As a community-based medical center, Christian Hospital provides full-service care where all areas of medicine are offered. Though the urology team has a variety of backgrounds, they share a common dedication to care and make themselves readily available to assist one another for the benefit of the patients they serve. That commitment to excellence includes nursing assistants who provide attentive care and ancillary staff who strategically rearrange already-packed schedules to accommodate patients' needs from most to least urgent. The urology department's recent acquisition of all urological care responsibility at Christian Hospital proves their eagerness to continue upholding the standard for medical excellence.

A majority of kidney patients end up losing their kidney in treatment, but according to Dr. Bullock, that number is less than 20 percent for patients under the care of Washington University urologic surgeons at Christian Hospital. He weighs in on another reason so many patients are referred to the hospital's urology

team: "the majority of our patients who've had their bladder removed will stand up at a urinal at a Cardinals game and the men next to him won't know he's missing his bladder. Most hospitals don't do that kind of surgery." Despite seeing a variety of patient cases, ranging from simple surgeries to more complex procedures, high success rates are consistent across the urology team. It's this level of performance that boosts the success of the department and the hospital as a whole.

Dr. Bullock hopes to carry on these stellar results at the new Siteman Cancer Center facility recently opened in north St. Louis County on the hospital's Northwest HealthCare campus. He shares the hospital's passion for increasing access to quality care for underserved communities and, as busy as he is, manages to continue his work in health outside of the hospital. Though his career is far from over, he hopes to one day focus more on the advocacy and mentorship that guided him throughout his accomplished career. Like Christian Hospital, Dr. Bullock's commitment and enthusiasm for providing care without conditions means the St. Louis community can continue to receive the outstanding medical care they deserve.

TAKING AN INNOVATIVE APPROACH TO HEART

For patients in need of a heart valve replacement, open-heart surgery might seem like the only option. Fortunately, advancements in heart procedures have led to minimally invasive alternatives, improving outcomes for patients.

One of these procedures is called transaortic valve replacement, or TAVR. Instead of opening the chest, TAVR replaces the aortic valve by threading a new valve through a small puncture site in the groin. This affords patients with a quicker recovery time and much less pain than open-heart surgery. TAVR is performed in a hybrid room, which combines the capabilities of a cardiac catheterization lab and a surgical operating room in one space. These specialized rooms are only available in around 2 percent of hospitals across the country.

In 2015, Christian Hospital opened its hybrid room, the only of its kind in north St. Louis County. The \$5.5 million modern facility allows Christian Hospital to perform the most advanced cardiac therapies, including TAVR. Funding for the hybrid room was primarily raised by the Christian Hospital Foundation, which received donations from the community as well as Christian Hospital physicians and staff.

Previously, TAVR was only offered to high-risk patients who fit a specific criteria. However, in August 2019, the U.S. Food and Drug Association (FDA) officially approved TAVR for low-risk patients with aortic stenosis. This new approval, stemming from excellent clinical trial results, gives these patients another alternative to traditional open-heart surgery.

Since the opening of the hybrid room four years ago, Christian Hospital has provided many patients with this state-of-the-art heart procedure. On Jan. 9, 2019, Donald E. Walker, 83, became the 100th TAVR patient at Christian Hospital. An avid walker and outdoorsman, Donald's heart condition left him unable to live his normal life. His physician referred him to the cardiology team at Christian Hospital who identified his need for a heart valve replacement. He was approved for TAVR.

After a short hospital stay of only two days, Donald returned to his home in Godfrey, Ill., with a new heart valve and very little pain.

"I have been favorably impressed by Christian Hospital. I like the people, and I like their approach," says Donald. "We were treated properly from the very beginning, always making sure we knew what we could expect."

Despite a gradual slowing down with age, Donald has been able to stay active. He enjoys fishing and canoeing on Lake Superior at the Canadian border, and he's grateful he can continue these trips thanks to the exceptional heart care made possible through support from the Christian Hospital Foundation.
